NEWARK AND SHERWOOD DISTRICT COUNCIL (No. 8) SMOKE CONTROL ORDER 1987

The Council for the District of Newark and Sherwood in exercise of the powers conferred upon them by Section 11 of the Clean Air Act, 1956 (as amended) hereby make the following Order:-

- 1. This Order may be cited as "The Newark and Sherwood District Council (No. 8) Smoke Control Order 1987".
- 2. The area which is coloured green on the map, prepared in duplicate, sealed with the Common Seal of the said Newark and Sherwood District Council and marked "Map referred to in the Newark and Sherwood District Council (No. 8) Smoke Control Order 1987," is hereby declared to be a smoke control area. One duplicate of the map is deposited in the Offices of the said Newark and Sherwood District Council and the other is deposited in the Offices of the Secretary of State for the Environment.
- 3. The fireplaces and classes of fireplaces in the area which are specified in the Schedule hereto, shall be exempted from the operation of the said Section 11 upon the conditions specified in respect thereof in the said Schedule.
- 4. This Order shall come into operation on the First day of October, One thousand Nine hundred and Eighty-eight.
